# City of Eldridge City Council Meeting Minutes

The City of Eldridge, Iowa met in an open session at Eldridge City Hall at 7:00 p.m., January 09, 2023.

Council Members Present: Bruce Cheek, Dan Collins, Brian Dockery, Bernie Peeters & Adrian Blackwell

Motion by Dockery to approve the agenda. Second by Blackwell. Motion approved unanimously by voice vote.

## Public Comment

Fire Chief Keith Schneckloth gave a report for the Fire Department for 2022. There were 826 calls in 2022. This has gone up 46 calls from the prior year. 683 were in Eldridge, and 79 were in rural Eldridge and the last 64 were to help other districts. Between 8 a.m. and 5 p.m., the department received 60% of the calls.

Motion by Collins to approve Resolution 2023-02 Mobile Food Unit Fees with amendment of the fee being \$125. Second by Cheek. Roll Call vote indicated Collins (Aye), Blackwell (Nay), Cheek (Aye), Peeters (Aye), and Dockery (Aye). Motion passes 4-1.

Motion by Blackwell to approve Resolution 2023-03 Final Plat of R & L Carriers. Second by Cheek. Roll Call vote indicated Blackwell (Aye), Cheek (Aye), Peeters (Aye), Dockery (Aye) and Collins (Aye). Motion passes 5-0.

The DOT sent an email to inform the council that they will be letting a project in February for DOT patching on Highway 61 from I-80 to County Road F33. Construction will begin this summer.

Motion by Dockery to approve Resolution 2023-04 authorizing the Mayor and City Staff to sign agreements with the Iowa DOT regarding the Townsend Farms Shared Use Path. Second by Peeters. Motion approved unanimously by voice vote.

Jon Burmeister with PFM Financial Advisors runs an annual sewer financial model for the City of Eldridge. Mr. Burmeister is recommending that the City of Eldridge increase sewer rates by 5% this year to accommodate sewer plant operations and bond payments. Ordinance 2023-02 has been prepared reflecting the recommended 5% increase. Rates will increase as follows for residential, commercial, and industrial users:

0 – 90,000 gallons will be increased from \$0.82/100 gallons to \$0.86/100 gallons

Over 90,000 gallons will be increased from \$0.72/100 gallons to \$0.76/100 gallons

Minimum monthly billing will increase from \$36.78 to \$38.62



## ORDINANCE 2023-02

**AN ORDINANCE REPEALING SECTIONS OF TITLE C, CHAPTER TWO OF THE ELDRIDGE CITY CODE, AND ADOPTING NEW SECTIONS 3.00 AND 3.01 ESTABLISHING NEW SEWER RATES, REPEALING ALL ORDINANCES AND RESOLUTIONS IN CONFLICT WITH THIS ORDINANCE AND PROVIDING FOR AN EFFECTIVE DATE.**

**Section One.** The portions of Section 3.00, Chapter Two, Title C, are hereby repealed and the following new language for Section 3.00 is hereby adopted.

3.00 Residential rates. Sewer rates for all single residential properties including property owned by any religious organization and used as a church, synagogue, or other place of worship, shall be based upon average water consumption as billed in the months of January February and March according to the schedule below. A single residential property is defined as a single-family home, an individual townhouse or row house, an apartment within a larger building, a mobile home or any grouping of rental rooms using a common bathroom. All residential users shall be charged the same rate regardless of the location where wastewater is treated.

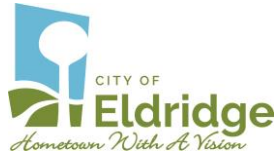

The bill, as determined by the average consumption described above, shall become effective with the April 1<sup>st</sup> billing of each year, and remain in effect until April 1<sup>st</sup> of the following year. Prior to April 1<sup>st</sup> of each year, average consumption shall be recalculated to determine if the residential customer's bill should be adjusted. Properties connected to sewer, but without metered water consumption, shall be subject to the minimum billing amount.

**Section Two.** The portions of Section 3.01, Chapter Two, Title C, of the Eldridge City Code are repealed and the following portion of Section 3.01 is hereby adopted.

3.01 Commercial and Industrial Rates. Sewer Rates for non-residential users, including schools, shall be based upon monthly water consumption. All nonresidential rates shall be charged the same rate regardless of the location wastewater is treated.

**Section three. Repealer.** All ordinances, resolutions, and parts of ordinances and resolutions in conflict with this ordinance are hereby repealed.

**Section four. Effective date.** This ordinance shall take effect upon its passage and publication as provided by law and become effective on April 1<sup>st</sup>, 2023.

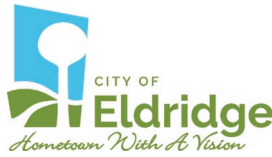

## ORDINANCE 2023-03

**AN ORDINANCE ADDING TITLE B, CHAPTER ONE, SECTION 9, OF THE ELDRIDGE CITY CODE REGULATING UTVS AND ATVS, REPEALING ALL ORDINANCES AND RESOLUTIONS IN CONFLICT WITH THIS ORDINANCE AND PROVIDING FOR AN EFFECTIVE DATE.**

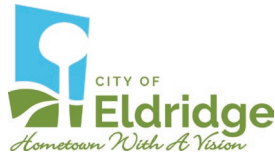
**Section one.** Title B, Chapter One is amended by adding the following language:

**9.01 PURPOSE.** The purpose of this chapter is to permit the operation of UTVs on streets in the City of Eldridge, Iowa. This chapter applies whenever a UTV is operated on any street or alley within the City of Eldridge. It is the intent to grant UTVs (when applicable) the same rights as a motor vehicle operating on a roadway, and to assign the same responsibilities as motor vehicle when being operated on a roadway.

### **9.02 DEFINITIONS**

1. UTVS. “Off-road utility vehicle” means a motorized vehicle with not less than four and not more than eight non-highway tires or rubberized tracks that has a seat that is of bucket or bench design, not intended to be straddled by the operator, and a steering wheel or control levers for control. UTV includes the following vehicles:  
(Code of Iowa, Sec. 321I.1)
  - A. UTV 1. “Off-road utility vehicle – type 1” includes vehicles with a total dry weight of 1,200 pounds or less and a width of 50 inches or less.
  - B. UTV 2. “Off-road utility vehicle – type 2” includes vehicles, other than type 1 vehicles, with a total dry weight of 2,000 pounds or less and a width of 65 inches or less.
  - C. UTV 3. “Off-road utility vehicle – type 3” includes vehicles with a total dry weight of more than 2,000 pounds or a width of more than 65 inches, or both.
2. ATVs. “All-terrain vehicle” means a motorized vehicle with not less than three and not more than six non-highway tires that is limited in engine displacement to less than one thousand cubic centimeters and in total dry weight to less than one thousand two hundred pounds and that has a seat or saddle designed to be straddled by the operator and handlebars for steering control.
3. ATVs, UTV 3s, and Tracked Vehicles Not Permitted. ATVs, UTV 3s, and tracked vehicles are not permitted on any Eldridge City Street, alley, park, or public property.
4. Exceptions. Persons employed by any city, county or federal agency; or municipal or public utility; or emergency personnel; while on the job are allowed to operate ATVs and UTVs for the express performance of their duties.

**9.03 GENERAL REGULATIONS/OPERATION OF UTVS PERMITTED.** UTVs may be operated upon the streets of the City by persons over the age of 18 who possess a valid Iowa operator's license, except as prohibited in Section 9.04 of this section. While operated on a City Street, the number of passengers permitted on a UTV shall not exceed the number of seats intended for passengers. While on city streets, operators must have



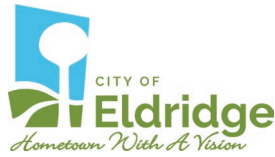
on their person, or in the UTV, valid proof of insurance. No UTV shall be operated at a speed more than the posted speed limit, nor shall any UTV be operated at a speed greater than is reasonable and proper for the existing conditions. No UTV shall be operated on streets with a speed limit greater than 35 miles per hour.

#### **9.04 PROHIBITED LOCATIONS**

1. UTVs shall not be operated on any recreational, bike or walking trail.
2. UTVs shall not be operated upon sidewalks.
3. UTVs shall not be operated upon that portion of a street right-of-way between the curb or edge of street paving and the sidewalk referred to as “parking”.
4. UTVs shall not be operated in City parks or upon other city owned land, except where regular vehicle traffic is permitted, unless authorized for a special event by the City Council.
5. The Chief of Police is authorized to permit UTVs to operate on restricted city areas for certain special events.
6. Prohibited Streets:
  - A. Blackhawk Trail from the eastern city limits to South 1<sup>st</sup> Street
  - B. Slopertown Road from the western city limits to South 1<sup>st</sup> Street
  - C. Buttermilk Road from Lincoln Road to the southern city limits
  - D. US Highway 61

**9.05 PERMITS.** No person shall operate a UTV on any public street or alley for any purpose unless the operator possesses a City of Eldridge, Iowa, permit to operate a UTV on City Streets, issued by the Eldridge Police Department Chief of Police or Authorized Designee (Deputy Chief or appointed Supervisor).

1. UTV owners must/shall apply for a permit from the Eldridge Police Department on forms provided by the Eldridge Police Department or printed off the Police Department city website.
2. The Chief of Police shall not issue a permit until the owner/operator provides the following:
  - A. Evidence that the operator is at least eighteen (18) years of age and possesses a valid driver’s license.
  - B. Proof owner/operator has financial liability insurance covering operation of UTV on city streets. Proof of current financial responsibility in accordance with Section 321.20B of the Code of Iowa. The owner/operator shall maintain such financial responsibility.
3. The applicant for a permit to operate a UTV on the city streets, as part of the application, shall verify the UTV complies with State Law and provisions of this Chapter.
4. The operator of a UTV shall prominently display the City of Eldridge permit on the LEFT side of the rear fender or similar component of the UTV.
5. Permits will run from April 1<sup>st</sup> of every year with only a 30-day grace period. All owner/operators will be required to complete the required paperwork each year following item numbers 1 – 5 of this section. Nonrenewal outside of the grace



- period is a violation of Iowa Code which can be cited by law enforcement officers.
6. UTV's must/shall adhere to Chapter 321 of the Code of Iowa regulating Motor Vehicles and Law of the Road.

**9.06 EQUIPMENT.** UTVs operated upon City streets shall be equipped with at least the following:

1. UTVs operated on city streets will be equipped with a muffler, headlights, taillights, turn signals, break lights, horn, seatbelts or safety restraints and adequate brakes to stop and hold the UTV in a stopped position. Driver and all passengers must comply with all seatbelt and occupant restraint requirements, including the use of child safety seats, as required for motor vehicles operating on a public roadway. Drivers and all passengers shall wear a properly adjusted safety belt or safety harness any time the UTV is in motion on city streets or alleys.
2. UTVs operated on city streets shall be equipped with an adequate exhaust system.

**9.07 HOURS OF OPERATION.** UTVs may be operated on City streets from 5:00 a.m. to 8:00 p.m.

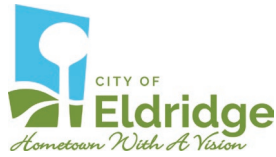
**9.08 TRAFFIC CODE.** Any person operating a UTV shall strictly adhere to all traffic signs and signals and all other traffic rules and regulations and shall obey the orders and direction of any law enforcement officer authorized to direct or regulate traffic. No person shall leave a UTV unattended on public property while the motor is running, or the keys are in the ignition switch. Any person operating an UTV under the influence of alcohol or controlled substance shall be processed under the State of Iowa OWI code 321J.2.

**9.09 ACCIDENT REPORTS.** Whenever an UTV, is involved in an accident resulting in injury or death to anyone or property damage amounting to one thousand five hundred dollars (\$1,500.00) or more, either the operator or someone acting for the operator shall immediately notify a law enforcement officer and shall file an accident report, in accordance with State Law. (Code of Iowa, Section 321I.11)

**9.10 VIOLATION AND PENALTY.** Any person who violates this Chapter is guilty of a simple misdemeanor and the standard penalty shall apply. Additionally, any person who violates this Chapter shall have his/her permit revoked for the following periods of time: First Offense: Fine of one-hundred dollars (\$100.00) and loss of permit for six (6) months.

Second Offense: Fine of two-hundred dollars (\$200.00) and loss of permit for one (1) year.

Third Offense: Fine of three-hundred dollars (\$300.00) and permit permanently revoked. A person who is in violation of this Ordinance may also be prosecuted, and subject to the penalties set out in Section 321I.36 of the Code of Iowa.

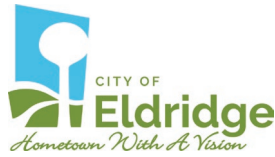

## ORDINANCE 2023-03

### AN ORDINANCE ADDING TITLE B, CHAPTER ONE, SECTION 10, OF THE ELDRIDGE CITY CODE REGULATING GOLF CARTS, REPEALING ALL ORDINANCES AND RESOLUTIONS IN CONFLICT WITH THIS ORDINANCE AND PROVIDING FOR AN EFFECTIVE DATE.

**Section one.** Title B, Chapter One is amended by adding the following language:

**10.01 PURPOSE.** The purpose of this chapter is to permit the operation of Golf Carts on certain streets in the City of Eldridge, Iowa, as authorized by Section 321.247, Code of Iowa, as amended. This chapter shall be applicable whenever a Golf Cart is operated on any street or alley, within the City of Eldridge as provided in this Chapter.

#### **10.02 DEFINITION.**

1. Golf Cart – means three or four wheeled recreational vehicle generally used for transportation of person(s) in the sport of golf.
2. Operate – means to ride in or on, other than as a passenger, use or control the operation of a golf cart in any manner, whether or not the golf cart is moving.
3. Operator – means a person, who operates or is in actual physical control of a golf cart
4. Roadway – means that portion of a highway improved, designated, or ordinarily used for vehicular travel.
5. Street or Highway – means the entire width between property lines of every way or place of whatever nature when any part thereof is open to the use of the public, as a matter of right, for the purpose of vehicular travel.

#### **10.03 General Regulations/Operation of Golf Carts Permitted.**

1. Golf Carts may be operated on the City Streets of Eldridge, Iowa, by persons possessing a valid driver's license and who are at least eighteen (18) years of age, except as otherwise prohibited by this Chapter or the Code of Iowa.
2. Golf Carts can only operate on city streets from Sunrise to Sunset.

#### **10.04 Location Restrictions for Golf Carts.**

1. Golf Carts shall not operate on a city street which is a primary road extension through the City of Eldridge, Iowa, but are allowed to cross a primary road extension.

Primary road extensions for purposes of this chapter, where golf carts shall not operate, include:

South 1<sup>st</sup> Street

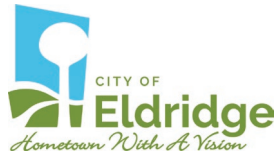
North 1<sup>st</sup> Street

West LeClaire Road

East LeClaire Road

North Buttermilk Road





South Buttermilk Road  
North Scott Park Road  
South Scott Park Road  
West Blackhawk Trail  
East Blackhawk Trail  
Slopertown Road  
West Lincoln Road  
East Lincoln Road  
Hillandale Road  
South Cody Road

2. Golf Carts shall not operate on any City Streets or Highway within the City Limits of Eldridge, Iowa, with a speed limit greater than 30 miles per hour.
3. Golf Carts shall not operate on any recreational, bike or walking trail.
4. Golf Carts shall not operate upon sidewalks.
5. Golf Carts shall not be operated upon that portion of a street right-of-way between the curb or edge of street paving and the sidewalk referred to as the “parking”.
6. Golf Carts shall not be operated upon any City Parks and other land owned by the City of Eldridge except in areas where regular vehicle traffic is allowed.
7. Golf Carts may be given special exemptions by the Chief of Police for certain special events.
8. Golf Carts may be operated on private property with express consent of the owner.

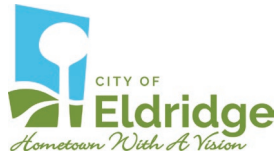
#### **10.05 Exceptions.**

Golf Carts may be operated on prohibited streets only under the following circumstances:

1. Golf carts may make a direct crossing of a prohibited street provided:
  - A. The crossing is made at an angle of approximately ninety degrees to the direction of the street and at a place where no obstruction prevents a quick and safe crossing.
  - B. The golf cart is brought to a complete stop before crossing the street.
  - C. In crossing a divided street, the crossing is made only at an intersection of such street with another street (Code of Iowa, Section 321G.9(2)).
2. Carts may be operated on any street when operated by an on-duty City of Eldridge Police Officer or Fire Fighter for official use.
3. Golf carts may be operated on any street when operated by an on-duty City of Eldridge employee or official that has the appropriate license and is doing work or volunteering for the Public Works, Streets, Electric, Water, Sewer Department, the Park Board, or the City of Eldridge.

#### **10.06 Permits.**

No person shall operate a Golf Cart on any public street or alley for any purpose unless the operator possesses a City of Eldridge, Iowa, permit to operate a Golf Cart on City Streets, issued by the Eldridge Police Department Chief of Police or Authorized Designee (Deputy Chief or appointed Supervisor).



1. Golf Cart owners must/shall apply for a permit from the Eldridge Police Department on forms provided by the Eldridge Police Department or printed from the Police Department city website.
2. The Chief of Police shall not issue a permit until the owner/operator provides the following:
  - A. Evidence that the operator is at least eighteen (18) years of age and possesses a valid driver's license.
  - B. Valid proof that the owner/operator has financial liability insurance covering operation of the golf cart(s) within the City of Eldridge, Iowa.
3. The applicant for a permit to operate a Golf Cart on the city streets, as part of the application shall verify the Golf Cart complies with State Law and provisions of this Chapter.
4. The operator of a Golf Cart shall prominently display the City of Eldridge permit on the LEFT side of the rear fender or similar component of the Golf Cart.
5. The fee for a permit to operate a Golf Cart on the city streets and alleys shall be thirty-five dollars (\$35.00) for the first year and twenty-five dollars (\$25.00) annually from the expiration of the first permit issued. There will be no refund for the permit.
6. Permits will run from April 1<sup>st</sup> of every year with only a 30-day grace period. All owner/operators will be required to complete the required paperwork each year following sections 1 – 5 of this section.
7. Failure to update your permit by the end of your 30-day grace period after April 1<sup>st</sup> of each year will require you to pay the thirty-five-dollar (\$35.00) permit fee. The Chief of Police has the authority to waive the late fee upon his own discretion.
8. Golf Carts must/shall adhere to Chapter 321 of the Code of Iowa regulating Motor Vehicles and Law of the Road.

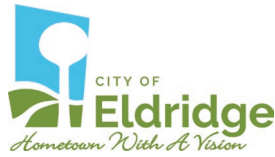
### **10.07 Equipment**

Golf Carts operated upon city streets within the City of Eldridge, Iowa, shall be equipped with the following items:

1. A bicycle safety flag, the top of which shall be a minimum of five (5) feet from ground level; if the golf cart has a canopy, the flag must be above the canopy.
2. A slow-moving vehicle triangle.
3. Properly functioning brakes.

### **10.08 Operation**

1. To operate a Golf cart on any city street, alley or right of way, a person shall be at least eighteen (18) years of age and shall have a valid driver's license. While on city street, operators must have on their person or in the Golf Cart valid proof of insurance and registration.
2. Any person operating a Golf Cart, including those for which a City of Eldridge permit has been issued, shall strictly adhere to all traffic signs and signals and all other traffic rules and regulations, and shall obey the orders and direction of any law enforcement officer authorized to direct or regulate traffic.



3. No person shall leave a Golf Cart unattended on public property while the motor is running, or keys are in the ignition switch. Owner/operators shall comply with all parking regulations in the City.
4. A person operating a Golf Cart shall not ride other than on a permanent seat which is designed to be a part of the Golf Cart and permanently attached thereto. No Golf Cart shall be used to carry more persons at a time than the number for which it is designed and equipped. All riders are required to be seated at all times.

### **10.09 Speed**

No Golf Cart shall be operated at a speed more than the lesser of twenty-five (25) miles per hour or a posted speed limit under twenty-five (25) miles per hour, nor shall any Golf Cart be operated at a speed greater than is reasonable and proper for the existing conditions.

### **10.10 Negligence**

The owner and operator of a Golf Cart is liable for any injury or damage occasioned by the negligent operation of the Golf Cart. The owner of a Golf Cart shall be liable for any such injury or damage only if the owner was the operator of the Golf Cart, at the time the injury or damage occurred, or if the operator had the owner's consent to operate the Golf Cart, at the time the injury or damage occurred. (Code of Iowa, Sec. 321I.19)

### **10.11 Accident Reports**

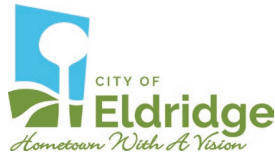
Whenever a Golf Cart, is involved in an accident resulting in injury or death to anyone or property damage amounting to One Thousand Five Hundred Dollars (\$1,500.00) or more, either the operator or someone acting for the operator shall immediately notify a law enforcement officer and shall file an accident report, in accordance with State Law. (Code of Iowa, Sec. 321I.11)

### **10.12 Golf Cart Insurance**

Financial responsibility is required – The owner/operator of every Golf Cart being operated upon the streets and alleys of the City of Eldridge, Iowa, shall have in effect liability insurance covering operation of the Golf Cart in the same limits, as required of automobiles by the financial responsibility provision of Section 321A.21 (Motor Vehicle Liability Policy) Code of Iowa.

### **10.13 Violation and Penalties**

1. Any person may be suspended or revoked by the Chief of Police upon receipt of sufficient evidence that permit holder has violated the conditions of the permit or has abused the privilege of being a permit holder.
2. Any person found guilty of violating the provisions herein for the first time, shall be guilty of a misdemeanor and shall be subject to a fine of one hundred dollars (\$100.00) and revocation of the City of Eldridge, Iowa, permit for a period of six (6) months.
3. Any person found guilty of violating this Ordinance two (2) times in a twelve (12) month period shall be guilty of a misdemeanor and shall be subject to a fine of



two hundred dollars (\$200.00) and revocation of the City of Eldridge, Iowa, permit for one (1) year.

- 4. Any person found guilty of violating this Ordinance three (3) times in a twelve (12) month period shall be guilty of a misdemeanor and shall be subject to a fine of three hundred dollars (\$300.00) and a permanent revocation of the City of Eldridge, Iowa, permit.
- 5. Any person who has been denied of a City of Eldridge, Iowa, permit due to violations and is found operating a Golf Cart within the City of Eldridge, Iowa, shall be guilty of a misdemeanor and shall be subject to a fine of five hundred dollars (\$500.00).
- 6. Any person who is in good standing, and who permits another person who has previously been deemed as “an unauthorized person to possess a permit” to drive their Golf Cart, shall be found guilty of a misdemeanor and shall be subject to a fine of two hundred dollars (\$200.00) for allowing an unauthorized person to drive. Additionally, revocation of the City of Eldridge, Iowa, permit for a period of two (2) months.

# ORDINANCE 2023-05

**AN ORDINANCE AMENDING TITLE B, CHAPTER ONE, SECTION 4.08 OF THE ELDRIDGE CITY CODE ADDING NO PARKING ZONES ON S. 14<sup>TH</sup> AVE., S. 16<sup>TH</sup> AVE., REPEALING ALL ORDINANCES AND RESOLUTIONS IN CONFLICT WITH THIS ORDINANCE AND PROVIDING FOR AN EFFECTIVE DATE.**

**Section One.** Title B, Chapter One, Section 4.08 No Parking Zones is amended by adding the following language:

The east side of South 14<sup>th</sup> Avenue from East LeClaire Road to South 16<sup>th</sup> Avenue.

The east side of South 16th Avenue from East LeClaire Road to the south edge of Aberrant First Addition Lot 2.

The west side of South 16<sup>th</sup> Avenue from south entrance to 400 S. 16<sup>th</sup> Avenue to South 14<sup>th</sup> Avenue.

**Section Two.** Repealer. All ordinances, resolutions, and parts of ordinances and resolutions in conflict with this ordinance are hereby repealed.

**Section Three.** Effective date. This ordinance shall take effect upon its passage and publication as provided by law.

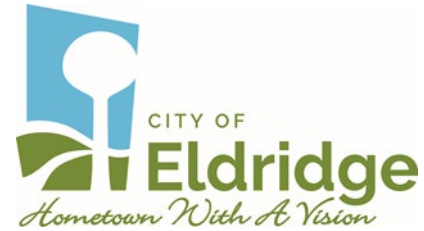

Mayor and City Council,

At the January 5, 2023, Board of Adjustment meeting Robinson Outdoor approached the board about placing a 10'x20' electronic billboard in the parking lot of QC Autoplex, 110 S. 9<sup>th</sup> Ave. owned by Joe Zrostlik and Scott Wolfe. This type of sign is allowed in a C-3 district with a Use on Review but would require variances due to the distance from nearest billboard in town and distance from nearest residential district at this location. During the course of this meeting questions were asked by the BOA concerning the age of our sign ordinance and how long it had been since the council reviewed it. They also wondered what the distance requirements are of surrounding communities.

The BOA and Councilman Cheek thought a review of this ordinance by the City Council might be in order before they took action to see if the current requirements still lined up with the vision of the council. The BOA asks that you review the following information and discuss it to see if you believe any changes to the distance requirements in our city off-premises sign ordinance are in order.

The Eldridge Off-Premise Advertising Sign distance requirements are currently ½ mile (2640') from the nearest other Off-Premise Advertising Sign (billboard) and 1000' from the nearest residential district.

The Iowa DOT requires the following distances between billboards / off premise advertising:  
 250 ft. in Cities and 500 ft. in rural areas.

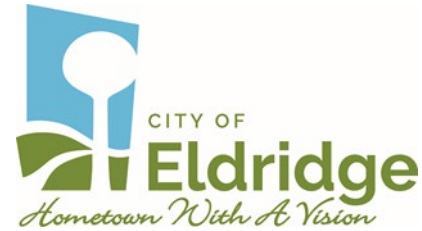
