Department update: The crew is tying up loose ends for the winter. Resco will be getting the transformers we ordered in production in April. Once we receive those we will be in a good position for upcoming subdivisions.

WATER- Resolution 2023-06 E&W approving the final acceptance of public improvements for TCC 1st Addition, was brought before the Board. Anderson made a motion to approve the resolution, second by O'Brien, all ayes.

Department update: The lead and copper samples were sent to the State Hygienic Lab in August, the lab lost the samples, and we are now in noncompliance with the DNR. Rowe is appealing their decision. He will keep the Board updated on the situation.
