All contractors shall supply a certificate or affidavit of insurance executed by a representative of a duly qualified insurance company evidencing that said the insurance company has issued liability and property damage insurance policies covering activities of said contractor in amounts not less than the following schedule. The contractor shall maintain such General Liability Insurance as shall protect him against claims for damages from 1) bodily injury, including wrongful death, and 2) property damage, which may arise from operations by himself or by any subcontractor or anyone directly or indirectly employed by either of them. The minimum acceptable limits are \$1,000,000 combined single limit per occurrence, and \$1,000,000 single limit aggregate.
