The regular meeting of the Board of Trustees of the Eldridge Electric and Water Utility Board was called to order at 5:00 p.m. on September 23rd, 2025, at Eldridge City Hall.

The board members present were Michael Bristley, Mark Goodding, Jeff Hamilton, Rachael Padavich, and Abby Petersen. Also present were Gage Lane, Nevada Lemke, Sadie Wagner, Cegan Long, Gabe Stricker, Ryan Iossi, Marty O' Boyle, and Dale Grunwald.

Public Comment: None.

Padavich Made a Motion to Approve the Agenda. Second by Petersen. All Ayes. Motion Carried.

Hamilton Made Motion to Approve of Utility Board Minutes from September 9th, 2025, Second by Padavich. All Ayes. Motion Carried.

Financial & Administrative

- A. Petersen Made Motion to Approve Bills Payable in the amount of \$ 67,024.71, Second by Padavich. All Ayes. Motion Carried.
- B. Padavich Made Motion to Approve Resolution 2025-15 E&W Repealing Resolution 2022-010 E&W Establishing changes to the Electric Department Pay Scale. Second by Hamilton, ROLL CALL Petersen (Aye), Goodding (Aye), Padavich (Aye), Hamilton (Aye), Bristley (Aye). Motion Carried.
- C. The Board held a discussion on interest rates and terms for T- Bills. The Board requested that the City Administrator bring back an arrangement for review at the next Utility Board meeting in October.
- D. Goodding Made Motion to approve amended Utility Billing Policy. Second by Hamilton. All Ayes. Motion Carried.
- E. Padavich Made Motion to Approve Resolution 2025-16 Repealing Resolution 2022-06 E&W Establishing Changes and Other Conditions to the Budget Billing Plan. Second Goodding, ROLL CALL Petersen (Aye), Goodding (Aye), Padavich (Aye), Hamilton (Aye), Bristley (Aye). Motion Carried.
- F. <u>Department Update-</u> Wagner met with Daupler and believes it would be beneficial to bring in the remaining departments to utilize their system to replace the existing answering service. She also received an email from Andy with Compass regarding the micro-planning resource auction and relayed the auction had been run incorrectly for a number of years and that MISO will be crediting for the current PY 25-26. Another email was received from Kevin with CIPCO to initiate conversation as CIPCO is proposing a generating facility project just outside of Maysville. The PCA for Quarter 3 has been reviewed and adjusted, and the increase will take effect on the 10/1/25 bill.

Electric Department

- A. <u>Outages-</u> On 9/13/25 at 2:00 PM, an outage occurred at 123 W. Spring Street due to a melted fuse on a transformer. Power was restored at 2:50 PM, with a total of 9 customers affected.
- B. **Department Update** The crew recently completed the IUC vegetation and tree trimming inspection, which will be sent to the trimming crews to obtain quotes and hire out. A new underground electrical service was also completed in preparation for the new car wash. Additionally, Devin and Dalton are out of town attending their IAMU training.

Water Department

- A. Water Main Breaks- None.
- B. Water Test Results- Bac-Ts passed. Water testing shows fluoride at the raw level. The fluoride pump will be repaired this week, returning levels to 0.7. All other tests came back negative, and the system remains in compliance.
- C. Discussion was had on PVC Water Main. No motion was made.
- D. Padavich Made a Motion to approve replacement clearwell float sensors. Second by Petersen. All Ayes, Motion Carried.
- E. Discussion was had for AC/Heater units for the power and chlorine rooms at the Water Treatment Plant. Petersen Made Motion to Table. Second by Padavich. All Ayes, Motion Carried.
- F. <u>Department Update –</u> The exterior sandblasting of the water tower is complete, and work has moved to the interior, with completion expected by the end of the week. Painting is planned to begin in early October. ACCO is replacing the fluoride and caustic pumps this week, along with the necessary hardware. Lino Instrumentation will be on-site on Thursday to calibrate testing equipment. The new meter reading system is fully operational and will start being used this week. Altorfer was out on Monday to test the stray voltage on the generator, and they did find stray voltage and fixed the ground wire in the hope of fixing the issue. ISG is in the final stages of completing the hydraulic model, and once it's complete, they will meet with the city to discuss recommendations and findings. Long was approved to take his Grade 4s.



Important Questions & Answers

What am I responsible for?

As a homeowner, you are responsible for your exterior water service line and exterior sewer/septic line on your property.

Does my homeowners insurance cover this?

Most basic homeowners insurance policies do not cover repair or replacement due to normal wear and tear of these lines.

Does this coverage include well lines?

Yes, coverage provides for repair or replacement of either water service or well lines, as explained in the "What's covered" section.

Who is eligible for coverage?

To be eligible, you must own both the residential single structure and the land it is located on. You are not eligible if your home is a recreational vehicle or otherwise intended to be moved; your property is used for commercial purposes; you know of any current problems with your exterior water service or exterior sewer/septic lines before enrollment, your entire line(s) is shared with a 3rd party or covered by a homeowners' association or the like, or your exterior sewer/septic line has failed a smoke or dye test, camera inspection or any other proactive test without resolution. In IA, properties with more than 4 dwelling units are not eligible.

What should I know about this coverage?

What's covered: Coverage provides, up to the applicable benefit limit, to repair or replace the following, that have experienced an operational failure, for which you have sole responsibility, that are damaged due to normal wear and tear, not accident or negligence. Exterior Water Service Line Coverage: The water line from your utility's responsibility or external wall of your well casing to the water meter or main shut-off valve inside your home. Repair or replacement of non-functioning stop boxes, shut-off valves, pressure reducing valves and backflow prevention devices is also covered. Exterior Sewer/ Septic Line Coverage: The sewer line from the external wall of your home up to your utility's responsibility, or septic line from the external wall of your home up to the point of connection to the septic tank on your property, including branch drains from the point they exit the home to the point they re-enter the home.

Not covered: Damage from accidents, negligence or otherwise caused by you, others or unusual circumstances and the following product-specific exclusions: Exterior Water Service Line Not Covered: Branch lines; any tanks or appliances. Additional exclusions apply. Exterior Sewer/Septic Line Not Covered: Septic/collection tanks; leaching fields; grinder pumps; nonconforming drain lines; or branch lines. Additional exclusions apply. See full Terms and Conditions with complete coverage and exclusion details prior to enrolling by calling 1-844-863-1416 or going to www.PlansfromSLWA.com. Costs on covered repairs may exceed the benefit limit, in which case you pay the difference between the cost and the benefit limit. Disputes resolved by arbitration, without class action or jury trial, unless otherwise stated in your full Terms and Conditions.

When can I make a service call?

Your plan(s) starts the day your enrollment is processed. There is an initial 30-day waiting period before you can make a service call, providing 11 months of coverage during the first year. Upon renewal/reactivation (if applicable), there is no waiting period.

What is the cancellation policy?

If you cancel within 30 days of your start date, you will get a full refund (less benefits paid, where applicable). Cancellations after the first 30 days will result in a pro-rata refund (less benefits paid, where applicable).

What is the term of my service agreement?

The plan(s) is annual. Unless you cancel, your plan(s) automatically renews annually at the then-current renewal price with your same payment terms.

What is E-Z Pav?

E-Z Pay is a paperless and stress-free way to pay for your coverage. Payments are automatically debited from the bank/checking account of your choice as your payment becomes due, at no additional cost.

- 2. The Electric & Water Utility shall adhere to the practices governed by the attached Financial Investment Policy when investing excess funds.
- 3. The Eldridge Electric & Water Utility Board of Trustees shall act in the capacity of Treasurer in accordance with Iowa Code Section 12B.10(1) and by and through the City Clerk shall be responsible for conducting investment transactions. In addition, the Utility Administrative Manager and City Administrator shall assist the Board in the reporting and accounting of investments and shall also assist in placing investments with financial institutions as directed by the Board and in accordance with Resolution #2025-19 E&W Naming Depositories.

ELDRIDGE, IOWA ELECTRIC & WATER UTILITY BOARD OF TRUSTEES FINANCIAL INVESTMENT POLICY

SECTION 1. SCOPE OF INVESTMENT POLICY

The Investment Policy of the **Eldridge Electric & Water Utility** of the City of Eldridge, Iowa shall apply to all operating funds, bond proceeds and other funds and all investment transactions involving operating funds, bond proceeds and other funds accounted for in the financial statements of the **Eldridge Electric & Water Utility** of the City of Eldridge, Iowa. Each investment made pursuant to this Investment Policy must be authorized by applicable law and this written Investment Policy.

The investment of bond funds or sinking funds shall comply not only with this investment policy, but also be consistent with any applicable bond resolution.

This Investment Policy is intended to comply with Iowa Code Chapter 12B.

Upon passage and upon future amendment, if any, copies of this Investment Policy shall be delivered to all of the following:

- 1. The governing body or officer of the **Eldridge Electric & Water Utility** to which the Investment Policy applies.
- 2. All depository institutions or fiduciaries for public funds of the **Eldridge Electric & Water Utility.**
- 3. The auditor engaged to audit any fund of the **Eldridge Electric &** Water Utility.
- 4. The State Auditor.

In addition, a copy of this Investment Policy shall be delivered to every fiduciary or third party assisting with or facilitating investment of the funds of the **Eldridge Electric &** Water Utility.

SECTION 2. DELEGATION OF AUTHORITY

In accordance with Iowa Code section 12B.10(l), the responsibility for conducting investment transactions resides with the Treasurer of the **Eldridge Electric & Water Utility**, which is the City Clerk of the City of Eldridge, Iowa pursuant to E&W Resolution 4.76.

Only the City Clerk and those authorized by resolution may invest public funds and a copy of any empowering resolution (E&W Resolution 4-76) shall be attached to this Investment Policy.

All contracts or agreements with outside persons investing public funds, advising on the investment of public funds, directing the deposit or investment of public funds or acting in a fiduciary capacity for the Eldridge Electric & Water Utility shall require the outside person to notify the Eldridge Electric & Water Utility in writing, within thirty days of receipt of all communication from the Auditor of the outside person or any regulatory authority, of the existence of a material weakness in internal control structure of the outside person or regulatory orders or sanctions regarding the type of services being provided to the Eldridge Electric & Water Utility by the outside person.

The records of investment transactions made by or on behalf of the Eldridge Electric & Water Utility, City of Eldridge, Iowa are public records and are the property of the Eldridge Electric & Water Utility, City of Eldridge, Iowa whether in the custody of the Eldridge Electric & Water Utility or in the custody of a fiduciary or other third party.

The City Clerk shall establish a written system of internal controls and investment practices. The controls shall be designed to prevent losses of public funds, to document those officers and employees of the **Eldridge Electric & Water Utility** responsible for elements of the investment process and to address the capability of investment management. The controls shall provide for receipt and review of the audited financial statement and related reports on internal control structure of all outside persons performing any of the following for the **Eldridge Electric & Water Utility**.

- 1. Investing public funds of the Eldridge Electric & Water Utility
- 2. Advising on the investment of public funds of the **Eldridge Electric & Water Utility**
- 3. Directing the deposit or investment of public funds of the **Eldridge Electric & Water Utility**
- 4. Acting in a fiduciary capacity for the Eldridge Electric & Water Utility

A Bank, Savings and Loan Association or Credit Union providing only depository services shall not be required to provide an audited financial statement and related report on internal control structure.

The City Clerk of and all employees authorized to place investments shall be bonded in the amount of \$200,000.00.

SECTION 3. OBJECTIVES OF INVESTMENT POLICY

The primary objectives, in order of priority, of all investment activities involving the financial assets of the **Eldridge Electric & Water Utility** shall be the following:

- 1. **Safety:** Safety and preservation of principal in the overall portfolio is the foremost investment objective.
- 2. **Liquidity:** Maintaining the necessary liquidity to match expected liabilities is the second investment objective.
- 3. **Return:** Obtaining a reasonable return is the third investment objective.

SECTION 4. PRUDENCE

The City Clerk, as the financial officer of the **Eldridge Electric & Water Utility** when investing or depositing public funds, shall exercise the care, prudence and diligence under the circumstances then prevailing that a person acting in a like capacity and familiar with such matters would use to attain the Section 2 investment objectives. This standard requires that when making investment decisions, the City Clerk shall consider the role that the investment or deposit plays within the portfolio of the **Eldridge Electric & Water Utility** assets of and the investment objectives stated in Section 3.

When investing assets of the **Eldridge Electric & Water Utility** for a period longer than two (2) years, the City Clerk shall request competitive investment proposals for comparable credit and term investments from a minimum of three (3) investment providers.

SECTION 5. INSTRUMENTS ELIGIBLE FOR INVESTMENT

Assets of the Eldridge Electric & Water Utility may be invested in the following:

• Interest bearing savings accounts, interest bearing money market accounts, and interest bearing checking accounts at any bank, savings and loan association or credit

Deposits in any financial institution shall not exceed the amount approved by the governing body of the Eldridge Electric & Water Utility Board of Trustees.

- Obligations of the United States government, its agencies and instrumentalities.
- Certificates of deposit and other evidences of deposit at federally insured Iowa depository institutions approved and secured pursuant to Iowa Code chapter 12C.
- Iowa Public Agency Investment Trust ("IPAIT").
- Prime bankers' acceptances that mature within 270 days of purchase and that are eligible for purchase by a federal reserve bank.
- Commercial paper or other short-term corporate debt that matures within 270 days of purchase and is rated within the two highest classifications, as established by at least one of the standard rating services approved by the Superintendent of Banking.
- Repurchase agreements, provided that the underlying collateral consists of obligations of the United States government, its agencies and instrumentalities and takes delivery of the collateral either directly or through an authorized custodian.
- An open-end management investment company registered with the Securities & Exchange Commission under the federal Investment Company Act of 1940, 15 U.S.C. Section 80(a) and operated in accordance with 17 C.F.R. Section 270.2a-7, whose portfolio investments are limited to those instruments individually authorized in this Section 5 of this Investment Policy.
- Warrants or improvement certificates of a levee or drainage district.

All instruments eligible for investment are further governed by all other provisions of this Investment Policy, including Section 7 Investment Maturity Limitations and Section 8, Diversification Requirements.

SECTION 6. PROHIBITED INVESTMENTS AND INVESTMENT PRACTICES

Assets of the Eldridge Electric & Water Utility shall not be invested in the following:

- 1. Reverse repurchase agreements.
- 2. Futures and options contracts.

Assets of the **Eldridge Electric & Water Utility** shall not be invested pursuant to the following investment practices:

- 1. Trading of securities for speculation or the realization of short-term trading gains.
- 2. Pursuant to a contract providing for the compensation of an agent or fiduciary based upon the performance of the invested assets.

If a fiduciary or other third party with custody of public investment transaction records of the Eldridge Electric & Water Utility fails to produce requested records when requested by the Eldridge Electric & Water Utility within a reasonable time, the Eldridge Electric & Water Utility shall make no new investment with or through the fiduciary or third party and shall not renew maturing investments with or through the fiduciary or third party.

SECTION 7. INVESTMENT MATURITY LIMITATIONS

Operating Funds must be identified and distinguished from all other funds available for investment. Operating Funds are defined as those funds which are reasonably expected to be expended during a current budget year or within fifteen months of receipt.

All investments authorized in Section 5 are further subject to the following investment maturity limitations:

- 1. Operating Funds may only be invested in instruments authorized in Section 5 of this Investment Policy that mature within three hundred ninety-seven (397) days.
- 2. The City Clerk may invest funds of the **Eldridge Electric & Water Utility** that are not identified as Operating Funds in investments with maturities longer than three hundred ninety-seven days (397) days. However, all investments of the **Eldridge Electric & Water Utility** shall have maturities that are consistent with the needs and use of the **Eldridge Electric & Water Utility**.

SECTION 8. DIVERSIFICATION

Investments of the **Eldridge Electric & Water Utility** are subject to the following diversification requirements:

Prime bankers' acceptances:

- 1. At the time of purchase, no more than ten percent (10%) of the investment portfolio of the **Eldridge Electric & Water Utility** shall be invested in prime bankers' acceptances; and
- 2. At the time of purchase, no more than five percent (5%) of the investment portfolio of the **Eldridge Electric & Water Utility** shall be invested in the securities of a single issuer.

Commercial paper or other short-term corporate debt:

- 1. At the time of purchase, no more than ten percent (10%) of the investment portfolio of the **Eldridge Electric & Water Utility** shall be in commercial paper or other short term corporate debt;
- 2. At the time of purchase, no more than five percent (5%) of the investment portfolio of the **Eldridge Electric & Water Utility** shall be invested in the securities of a single issuer; and
- 3. At the time of purchase, no more than five percent (5%) of all amounts invested in commercial paper and other short-term corporate debt shall be invested in paper and debt rated in the second highest classification.

Where possible, it is the policy of the **Eldridge Electric & Water Utility** to diversify its investment portfolio. Assets shall be diversified to eliminate the risk of loss resulting from overconcentration of assets in a specific maturity, a specific issuer, or a specific class of securities. In establishing specific diversification strategies, the following general policies and constraints shall apply:

1. Portfolio maturities shall be staggered in a way that avoid undue concentration of assets in a specific maturity sector. Maturities shall be selected which provide stability of income and reasonable liquidity.

- 2. Liquidity practices to ensure that the next disbursement date and payroll date are covered through maturing investments, marketable U.S. Treasury bills or cash on hand shall be used at all times.
- 3. Risks of market price volatility shall be controlled through maturity diversification so that aggregate price losses on Instruments with maturities approaching one year shall not be greater than coupon interest and Investment Income received from the balance of the portfolio.

SECTION 9. SAFEKEEPING AND CUSTODY

All invested assets of the **Eldridge Electric & Water Utility** involving the use of a public funds custodial agreement, as defined in Iowa Code section 12B.10C, shall comply with all rules adopted pursuant to Iowa Code section 12B.10C. All custodial agreements shall be in writing and shall contain a provision that all custodial services be provided in accordance with the laws of the state of Iowa.

All invested assets of the **Eldridge Electric & Water Utility** eligible for physical delivery shall be secured by having them held at a third party custodian. All purchased investments shall be held pursuant to a written third party custodial agreement requiring delivery versus payment and compliance with all rules set out in this Section 9.

SECTION 10. ETHICS AND CONFLICT OF INTEREST

The City Clerk and all officers and employees of the **Eldridge Electric & Water Utility** involved in the investment process shall refrain from personal business activity that could conflict with proper execution of the investment program, or which could impair their ability to make impartial investment decisions. Any personal investments or loans in excess of \$200,000 in or with any entity that the **Eldridge Electric & Water Utility** has declared as a depository or with which the **Eldridge Electric & Water Utility** regularly conducts investment business shall be disclosed in writing to the governing body of the City of Eldridge and the Eldridge Electric & Water Utility.

SECTION 11. REPORTING

The City Clerk shall submit the **Eldridge Electric & Water Utility** an investment report that summarizes recent market conditions and investment strategies employed since the last investment report. The investment report shall set out the current portfolio in terms of maturity, rates of return and other features and summarize all investment transactions that have occurred during the reporting period and compare the investment results with the budgetary expectations.

SECTION 12. INVESTMENT POLICY REVIEW AND AMENDMENT

This Investment Policy shall be reviewed every three (3) years or more frequently as appropriate. Notice of amendments to the Investment Policy shall be promptly given to all parties noted in Section 1.



SECOND AMENDED AND RESTATED AGREEMENT TO ESTABLISH THE IOWA PUBLIC POWER AGENCY

This Agreement by and among the Board of Trustees of the Algona Municipal Utilities, the Board of Waterworks and Electric Light and Power Plant Trustees, of Atlantic, the Board of Trustees of the Traer Municipal Utilities, the City of Auburn, Iowa Municipal Electric Utility, the City of Breda, Iowa Municipal Electric Utility, the Board of Trustees of Eldridge Municipal Electric Utility, the City of Fairbank, Iowa Municipal Utilities, the City of Fonda, Iowa Municipal Electric Utility, the Board of Trustees of Independence Light and Power, the City of Lake View, Iowa Municipal Electric Utility, the Board of Trustees of Montezuma Municipal Light and Power, the City of Pocahontas, Iowa Municipal Electric Utility, the City of Readlyn, Iowa Municipal Utilities, the City of Wall Lake, Iowa Municipal Electric Utility, and the Board of Trustees of Waverly Utilities, is an agreement to permit municipal utilities, electric power agencies, and electric joint action agencies, each of which is a political subdivision of the State of Iowa, to jointly make efficient use of their powers by enabling them to cooperate to form and participate in the Iowa Public Power Agency.

THE PARTIES AGREE as follows:

- 1. <u>PARTIES</u>. The parties to this Agreement are as follows:
- A. Algona Municipal Utilities, a municipal utility organized and existing under provisions of Chapters 384 and 388, City Code of Iowa. The Utility is located in the City of Algona, in the County of Kossuth, State of Iowa, with its principal office at 104 West Call Street, P.O. Box 10, Algona, Iowa 50511.
- B. Atlantic Waterworks and Electric Light and Power Plant, a municipal utility organized and existing under provisions of Chapters 384 and 388, City Code of Iowa. The Utility is located in the City of Atlantic, in the County of Cass, State of Iowa, with its principal office at 15 W. 3rd Street, P.O. Box 517, Atlantic, Iowa 50022-0517.
- C. Traer Municipal Utilities, a municipal utility organized and existing under provisions of Chapters 384 and 388, City Code of Iowa. The Utility is located in

the City of Traer, in the County of Tama, State of Iowa, with its principal office at 649 2nd Street, Traer, Iowa 50675-1230.

- D. Auburn Municipal Electric Utility, a municipal utility organized and existing under provisions of Chapters 384 and 388, City Code of Iowa. The Utility is located in the City of Auburn, County of Sac, State of Iowa, with its principal office at 209 Pine Street, P.O. Box 238, Auburn, Iowa 51433.
- E. Breda Municipal Electric Utility, a municipal utility organized and existing under provisions of Chapters 384 and 388, City Code of Iowa. The Utility is located in the City of Breda, County of Carroll, State of Iowa, with its principal office at 108 N. 2nd Street, P.O. Box 129, Breda, Iowa 51436.
- F. Eldridge Municipal Electric Utility, a municipal utility organized and existing under provisions of Chapters 384 and 388, City Code of Iowa. The Utility is located in the City of Eldridge, County of Scott, State of Iowa, with its principal office at 305 N. 3rd Street, Eldridge, Iowa 52748.
- G. Fairbank Municipal Utilities, a municipal utility organized and existing under provisions of Chapters 384 and 388, City Code of Iowa. The Utility is located in the City of Fairbank, County of Buchanan, State of Iowa, with its principal office at 116 East Main Street, P.O. Box 447, Fairbank, Iowa 50629.
- H. Fonda Municipal Electric Utility, a municipal utility organized and existing under provisions of Chapters 384 and 388, City Code of Iowa. The Utility is located in the City of Fonda, County of Pocahontas, State of Iowa, with its principal office at 104 West 2nd Street, Fonda, Iowa 50540.
- I. Independence Light and Power, a municipal utility organized and existing under provisions of Chapters 384 and 388, City Code of Iowa. The Utility is located in the City of Independence, County of Buchanan, State of Iowa, with its principal office at 700 7th Avenue NE, Independence, Iowa 50644.
- J. Lake View Municipal Electric Utility, a municipal utility organized and existing under provisions of Chapters 384 and 388, City Code of Iowa. The Utility

is located in the City of Lake View, County of Sac, State of Iowa, with its principal office at 305 Main Street, Lake View, Iowa 51450.

- K. Montezuma Municipal Light and Power, a municipal utility organized and existing under provisions of Chapters 384 and 388, City Code of Iowa. The Utility is located in the City of Montezuma, County of Poweshiek, State of Iowa, with its principal office at 501 E. Main Street, P.O. Box 340, Montezuma, Iowa 50171.
- L. Pocahontas Municipal Electric Utility, a municipal utility organized and existing under provisions of Chapters 384 and 388, City Code of Iowa. The Utility is located in the City of Pocahontas, County of Pocahontas, State of Iowa, with its principal office at 23 West Elm Avenue, P.O. Box 69, Pocahontas, Iowa 50574.
- M. Readlyn Municipal Utilities, a municipal utility organized and existing under provisions of Chapters 384 and 388, City Code of Iowa. The Utility is located in the City of Readlyn, County of Bremer, State of Iowa, with its principal office at 307 Main Street, P.O. Box 70, Readlyn, Iowa 50668.
- N. Wall Lake Municipal Electric Utility, a municipal utility organized and existing under provisions of Chapters 384 and 388, City Code of Iowa. The Utility is located in the City of Wall Lake, County of Sac, State of Iowa, with its principal office at 108 Boyer Street, Wall Lake, Iowa 51466.
- O. Waverly Utilities, a municipal utility organized and existing under provisions of Chapters 384 and 388, City Code of Iowa. The Utility is located in the City of Waverly, County of Bremer, State of Iowa, with its principal office at 1002 Adams Parkway, Waverly, Iowa 50677.

And such other municipal utilities, electric power agencies and electric joint action agencies, each of which must be a political subdivision of the State of Iowa, as shall apply and be approved as a party to this Agreement as provided herein. Only municipal utilities, electric power agencies and electric joint action agencies which are political subdivisions of the State of Iowa are eligible to be parties to this Agreement,

- PURPOSE. The purpose of this Agreement is to provide a means by which the parties may jointly and cooperatively proceed under the provisions of Chapters 28E, 28F and Sections 390.9 through 390.25 (formerly Sections 476A.20 through 476A.36), Code of Iowa, 2025, as amended, to establish an electric power agency known as the Iowa Public Power Agency (IPPA), operating through an Iowa nonprofit corporation to be formed by the parties to this Agreement, carry out a project or projects, carry out agreements, purchase and sell electric power and energy, purchase or construct facilities and otherwise exercise all powers conferred by Chapters 28E, 28F and Sections 390.9 through 390.25 of the Code of Iowa, 2025, as amended, and issue its public bonds or obligations as it deems necessary to carry out its purposes. In establishing IPPA, these parties, and any other municipal utility, electric power agency or electric joint action agency which is a political subdivision of the State of Iowa and which becomes party to this Agreement by application as provided in this Agreement, may exercise powers, privileges or authority, and make use of benefits jointly to which each of the parties separately is entitled under state and federal legislative acts, and may exercise all powers of an electric power agency under the laws of Iowa; provided, however, that nothing herein shall prevent any of the parties hereto, or participants, from separately applying for any such benefits to which they may be entitled.
- 3. <u>NAME</u>. The name under which the joint and cooperative activity shall be carried out is the IOWA PUBLIC POWER AGENCY. The Board of Directors hereinafter established may apply for and register such other fictitious or trade names as it may determine.
- 4. <u>ORGANIZATION</u>. The parties agree to form and participate in an Iowa nonprofit corporation, established under Chapter 504A, to be known as the IOWA PUBLIC POWER AGENCY, as more particularly described in the Articles of Incorporation attached hereto as Exhibit A. IPPA shall adopt bylaws which contain provisions setting out the method of electing directors, method of calling and holding meetings of the board of directors, defining the classes of membership, and such other provisions for the regulation and management of the IPPA not inconsistent with law, this Agreement, or the Articles of Incorporation. The Board of Directors of IPPA shall always be named, appointed or elected by the members.

- 5. <u>DURATION</u>. This Agreement shall become effective upon execution by the parties hereto and filing with the Secretary of State of Iowa, and shall continue in effect indefinitely until it is terminated as herein provided.
- 6. <u>POWERS</u>. The Board of Directors of IPPA shall have all powers, privileges and authority necessary and incidental to manage the affairs of IPPA and to carry out the intent and purpose of this Agreement, not inconsistent with law, this Agreement, or the Articles of Incorporation.
- 7. <u>GOVERNANCE</u>. The initial Board of Directors as of the effective date of this Agreement shall be:

Greg Fritz, NIMECA - President;
Gage Huston, Muscatine Power and Water – Vice President;
John Bilsten, Algona Municipal Utilities – Secretary/Treasurer;
Kyle Yates, SIMECA;
Kevin Kudart, Montezuma Municipal Light and Power;
Terry Wolf, Missouri River Energy Services.

The initial Board of Directors shall serve until their successors have been duly appointed and qualified in accordance with this Agreement and the Articles of Incorporation and Bylaws of the corporation. Thereafter, the Board of Directors shall consist of not less than three but not more than the total number of members of IPPA and shall be named, appointed or elected by the members of IPPA.

The members of the Board of Directors of IPPA shall be employees or governing body members of municipal utilities, electric power agencies or electric joint action agencies which are members of IPPA and political subdivisions of the State of Iowa.

8. <u>ADMINISTRATION</u>. The Board of Directors shall designate an administrative officer of IPPA and a secretary of the Board of Directors. The administrative officer and secretary shall serve at the pleasure of the Board of Directors and may be replaced by the Board of Directors at any time.

9. <u>FINANCE</u>. The IPPA shall not be operated for private profit, but shall be operated for the public purposes stated in Section 2 of this Agreement to enhance the financial welfare of the municipal utilities, electric power agencies and electric joint action agencies who are political subdivisions and members of IPPA.

The Board of Directors of the IPPA shall operate on a calendar year basis and shall establish an operating budget which shall include all revenue and expense, including without limitation, revenue from dues and contracts and all expenses of administration, operation, maintenance, and other revenue and expenses. Each member shall pay for contracted services and shall make payments for contracted services as provided in the contract.

To the extent that a participating member by contract authorizes the issuance of public bonds or obligations on its behalf or contracts to purchase from IPPA, the member shall be obligated to make such payments and repayments as may be required by the contract and shall pledge and dedicate all or part of the revenues of the member for the payment of the contract or public bonds or obligations.

- 10. <u>ADDITIONAL PARTIES</u>. Any municipal utility, electric power agency or electric joint action agency which is a political subdivision of the State of Iowa, may join in this Agreement by making application to the secretary of IPPA. The secretary and the Board of Directors are authorized to approve the application and agreement upon a determination that the requirements of participation have been met. Upon approval by the secretary and the Board of Directors and filing with the Secretary of State, the applicant shall be a party to this Agreement and a member of IPPA and shall be bound by the terms and conditions of this Agreement.
- 11. <u>TERMINATION AND DISPOSITION OF PROPERTY</u>. This Agreement may be terminated by a vote of a majority of the members, and IPPA may be dissolved or liquidated in accordance with the Articles of Incorporation attached hereto as Exhibit A.

Any member may withdraw from this Agreement upon giving one year's written notice to the other members. Such notice may be waived by the Board of Directors for good cause shown. Any member withdrawing must make payment of all amounts then due IPPA. All contracts and obligations of the member shall survive the withdrawal. Members may withdraw from IPPA in accordance with the Articles of Incorporation attached hereto as Exhibit A and such Bylaws as may be adopted by IPPA. Withdrawal by a member shall not constitute termination of the Agreement nor void any contract for services. A party so withdrawing shall have no claim on the assets of IPPA.

If this Agreement is terminated, all assets of IPPA shall be distributed as provided in the Articles of Incorporation attached hereto as Exhibit A. Upon dissolution or other liquidation, only members may receive any benefit as a result of participation in the Agency. On termination of this Agreement and dissolution or other liquidation of IPPA, all property and assets remaining after payment of liabilities shall be distributed in accordance with the plan of distribution adopted by the Board of Directors of IPPA.

12. <u>AMENDMENTS</u>. This Agreement may be amended by a written instrument approved by a majority of the parties to this Agreement at the time of the amendment. The Articles of Incorporation of IPPA may be amended as provided in the Articles of Incorporation attached hereto as Exhibit A, or in such manner as may be hereafter prescribed under the laws of the State of Iowa.
